| Affiliates   | <ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Our affiliates include companies that are owned by a common parent company.</li> </ul>   |  |  |
| Non-affiliates   | <ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Nonaffiliates we share with can include direct marketing companies.</li> </ul>   |  |  |
| Joint marketing  | <ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include program managers for stored value cards.</li> </ul>  |  |  |
